2. P.M. session Monday, Wednesday, Friday 12:30 p.m. to 3:00 p.m. \$300.00/month
3. Pre-K Monday, Wednesday, Friday 9:00 a.m. to 3:00 p.m. \$500.00/month
4. Lunch bunch 11:30 a.m. to 12:30 p.m. \$60.00/month
5. Pre-K Five Day program: Monday through Friday  
a. 9:00 a.m. to 3:00 p.m. \$200.00/week
6. Early drop off 8:00 a.m. (\$7 a day)  
\*Due at the end of each month reflective of the number of days used.
7. Extended day pick up by 4:00 p.m. (\$7 a day)  
\*Due at the end of each month reflective of the number of days used.

**General information:**

- The first tuition payment is due by June 1<sup>st</sup>. This becomes the June payment for school year. This is non-refundable. If a payment is not received, a spot will not be held for September.
- Tuition is due for the remainder of the year on the first of the month. (Example: Sept. 1<sup>st</sup>, Oct. 1<sup>st</sup>, Nov. 1<sup>st</sup>, Dec. 1<sup>st</sup>, Jan. 1<sup>st</sup>, Feb. 1<sup>st</sup>, March 1<sup>st</sup>, April 1<sup>st</sup>, May 1<sup>st</sup>)
- Payments received after the tenth of the month will be subject to a \$30.00 fee.
- Checks are made payable to St. Therese Nursery School
- Please use the tuition envelopes provided and place in the drop box in the nursery hallway.
- There are no reimbursements for a sick day, snow day, or vacation days that do not follow our calendar.
- The federal tax identification number is available by inquiring with the director.
- Siblings receive a tuition rate of the older child at full rate and the younger at a 25 percent discount.
